- 23/03. <u>To agree the minutes of the Parish Council meeting held on Thursday 10th November 2022</u> The minutes of the meeting on Thursday 10th November 2022 were approved and signed.

23/05. To receive reports:

- (i) John Toye (North Norfolk District Councillor) Next group meeting will be on 7th March in Aldborough, two Planning Officers will attend. Several people have raised highways issues, so a larger campaign will be looked at. Battery recycling has now started. Small electricals can be recycled from March. The Reef is doing very well, and a solar panel roof will soon cover the car park. Sheringham Little Theatre is being refurbished, and Cromer Pier work has been approved.
- (ii) Saul Penfold (Norfolk County Councillor) The County Deal for Norfolk is being discussed, which is part of the Government's devolution plans. The leader of the Council is minded to accept it, but it will need to be agreed at Full Council. This would mean £20 million per year for 30 years (not index linked). There is currently a public consultation open for people to respond to. Budget setting is in progress, but the Council is currently running a £900 million deficit. Children's Services received a Good Ofsted rating, up from Requires Improvement.
